

WIN AN AUTUMN HOME REFRESH PROMOTION

1. Information on how to enter and prizes form part of these terms and conditions. Entry into the Aspley Homemaker City Autumn Home Makeover Promotion (“Promotion”) is deemed to be an acceptance of the following terms and conditions. Entries must comply with these conditions to be valid.
2. **Who cannot enter?** Employees of Aspley Homemaker City, their immediate families, retailers within Aspley Homemaker City, the retailers’ employees and their immediate families are all ineligible to enter.
